DOCTOR DISSERTATION DEFENSE

The Process

This presentation will be thoroughly evaluated, and the quality and depth of the research will play a significant role in the candidate's eligibility for receiving their doctoral degree.

2. **Focus on Key Findings:** Emphasize the most important aspects of your research, particularly your findings and how they contribute to the field.
3. **Prepare for Questions:** Be ready to answer questions that may arise from your video presentation, addressing potential weaknesses or areas requiring further explanation.
4. **Professional Presentation:** Ensure the video is clear, with good audio and visual quality. Maintain a professional appearance and speak clearly.
5. **Timing:** Adhere to any time limits provided for the presentation. Practice beforehand to ensure your presentation fits within the allotted time frame.

By following these guidelines, you will ensure that your dissertation defense is both thorough and professional, enhancing your chances of success in receiving your doctoral degree.

A suggested time limit for a doctoral dissertation defense video presentation typically ranges from 20 to 30 minutes. This is long enough to cover the essential components of your research—such as the introduction, literature review, methodology, key findings, and conclusions—without overwhelming the committee with excessive detail.

Here's a suggested breakdown:

- **Introduction (2-3 minutes):** Briefly introduce the research question, objectives, and importance of the study.
- **Literature Review (4-5 minutes):** Summarize the key literature that informed your research.
- **Methodology (3-5 minutes):** Describe the research design, methods, and tools used.
- **Key Findings (8-10 minutes):** Present the main findings and their implications.
- **Conclusion (3-4 minutes):** Summarize your conclusions, contributions to the field, and potential areas for future research.

Be sure to practice your presentation to ensure it stays within the time limit while still providing enough depth and detail for the committee to assess your work.
